

At a time when millions of vulnerable Syrians in their various demographics, which include displaced persons, refugees, and those burdened by the suffering of twelve years, are looking to the international community and its United Nations to find a just political solution that will do them justice and enable them to realize their rights like any people, to live a free and dignified life, these very Syrians are once again forced to demand from this international community what is much less than that; they just demand that this international community succeed in enabling these Syrians to obtain their most basic rights in surviving after they have been displaced and dispersed in the geography of the earth by a regime that exercised all methods of slavery, oppression, killing, and displacement.

Since 2014, the Security Council has adopted a United Nations resolution to allow cross-border aid to areas outside the Syrian regime's control. That resolution could not have been taken without the international community's certainty that this regime, which caused tragedy for millions of Syrians, would not have provided any of the basic necessities of life, including health care, access to clean water, food, and education.

UN Resolution 2585 and previous relevant resolutions have played an important and insufficient role in responding to the priorities of the needs of the Syrians in northwest Syria in preserving the lives of people despite the worsening needs and in light of the exceptional humanitarian conditions that lack the most basic necessities of life and a decent life for the two million displaced people in the camps and more than three million others who are not better off than them, especially with the spread of the Covid-19 pandemic and the worsening international chaos after the Russian invasion of Ukraine and its continuous economic effects.

The failure of the United Nations Security Council, at its meeting scheduled for 10 July 2022, to renew that United Nations resolution would have catastrophic effects, which the members of the Council must be aware of as guarantors of peace, international stability, and the promotion of human rights. Not the least of these effects is the denial of access to the most basic necessities of life for millions of Syrians in northwest Syria and thus more waves of migration, displacement, and chaos. Attempts to deliver aid across the cross-lines have proven to be weak and inefficient. On the one hand, there is a loss of trust between Syrians and the regime, which will use this aid as a tool to extort and subjugate its opponents. On the other hand, it will use this aid to transfer it to its supporters, which has been proven by many reports from human rights organizations. The international community must be aware that, despite all the calls for voluntary return, all these calls have failed in their blatant disregard for a just political solution.

Therefore, the Syrian Legal Platform calls on the members of the Security Council and the international community to extend the United Nations resolution on allowing the provision of aid across the border, as it is important for the survival of more than five million people, and for those affected by this resolution not to be an instrument of political extortion among states, and for those states to assume their responsibilities and work with the rightful Syrians to find a just and sustainable political solution.
